2024-01.02-A Resolution to Adopt a Policy on Information Request Made By Individual Commissioners. All Information requests to the Housing Authority of the City of Hoboken made by individual Commissioners pertaining to the business of the Authority must be made, in writing, to the Executive Director of the Authority. Upon receipt of any such request, the Executive Director shall have fourteen business days, weekends and Authority holidays excluded, to respond to any such request, either by: (1) providing the information requested; or (2) stating, in writing, that the information requested could not reasonably be provided within the fourteen business-day period and setting forth a date by which the requestor can expect a complete response.
